ORDINANCE 2025-2

AN ORDINANCE REPEALING ORDINANCE NO. 2024-1 AND PROVIDING FOR A MONTHLY SERVICE CHARGE FOR THE USE OF THE WATER AND SEWER SYSTEM. DEFINING THE TERMS, SETTING THE AMOUNT OF SAID CHARGE AND PROVIDING PENALTIES FOR A FAILURE TO PAY SAID CHARGE.

NOW, therefore, be it ordained by the Board of Alderman for the City of Galena, Missouri as flows:

Ordinance no. 2024-1 is hereby repealed.



APPENDIX "A"

WATER RESIDENTIAL

The following rates shall be charged for water based on water usage:

SERVICE INSIDE CITY LIMITS	*\$15.31 Base Rate, plus \$3.65 for each 1,000 gallons, Or fraction thereof, used during the month:
SERVICE OUTSIDE CITY LIMITS:	*\$20.76 Base Rate, plus \$5.45 for each 1,000 gallons, Or fraction thereof, used during the month:
PRIVATE USE AND TANKS:	For other non-metered occasional use in tanks, trucks, Or other containers \$15.31 Base Rate, \$3.65 per 1,000 Gallons
LATE FEE	\$10.00 Per Bill

Shall be a (9) nine percent annum interest owed on late fees

Reconnect Charge:

After a customer has been disconnected from the water system, she/ he may be allowed to again use the water system after all delinquent water and sewer charges have been paid in full together.

After a customer has been disconnected from the water system there will be a \$30.00 fee, she/he

May be allowed again after all charges have been paid in full to reconnect for a \$30.00 fee.

This will be a annual 2% increase for 5 years.

***NOTE-** no usage shall be included in the Base Rate.

WATER COMMERCIAL

The following rates shall be charged for water based on water usage:

SERVICE INSIDE CITY LIMITS	*\$15.31 Base Rate, plus \$8.24 for each 1,000 Gallons, or fraction thereof, used during the month:
SERVICE OUTSIDE CITY LIMITS	*\$20.76 Base Rate, plus \$5.45 for each 1,000 Gallons, or fraction thereof, used during the month:
PRIVATE USE AND TANKS	For other non-metered occasional use in tanks, Trucks, or other containers, \$15.31 base rate plus \$8.24 per 1,000 gallons.
LATE FEE	\$20.00 Per Bill

Shall be a (9) percent annum interest owed on late fees

This will be a annual 2% increase for 5 years

Reconnect Charge

After a customer has been disconnected from the water system, she/ he may be allowed to again use the water system after all delinquent water and sewer charges have been paid in full together.

After a customer has been disconnected from the water system there will be a \$30.00 fee, she/he

May be allowed again after all charges have been paid in full to reconnect for a \$30.00 fee.

***NOTE- no usage shall be included in the Base Rate.**

APPENDIX "C"

SEWER RESIDENTIAL

The following rates shall be charged for sewer based on the volume measured in water usage:

1. Residential sewer rate schedule:

- a. Sewer service charge base rate \$17.64 per month*
- b. Charge for usage \$ 9.42 per 1,000 gallons of water usage,
of fraction thereof**

2. Late Fee

- a. Late Fee \$10.00

3. Shall be a (9) nine percent annum interest owed on late fees

4. Extra charge for high strength waste:

- a. B.O.D \$0.81 per pound
- b. Suspended solids (s.s) \$0.15 Per pound
- c. Toxic substances All actual cost associated with or resulting from
Discharge of this type of material to the sewer system.

5. Reconnect charge:

After a customer has been disconnected from the sewer system. She/he may be allowed again use of the sewer system after all delinquent water and sewer charges have been paid in full together. A special disconnect charge of \$300.00 shall be imposed if the sewer service is disconnected and a \$300.00 reconnect fee shall be imposed.

This will be an annual 2% increase for 5 years

*NOTE No usage shall be included in the service charge.

** In the event a customer moves in after the averaging time period, they will be billed monthly until the next averaging occurs.

This will be an annual 2% increase for 5 years.

*NOTE No usage shall be included in the service charge.
